# 7B. Consider a resolution authorizing a purchase order for fiscal year 2023 fee and payment processing services.

Consider action to approve a resolution authorizing a purchase order for payment in the amount of \$119,000 to Paymentus for fiscal year 2023 for fee and payment processing services.

## 7C. Consider action authorizing payment for computer software maintenance and support services.
