#### 7B. Consider action approving a Tree Removal Permit application.

Consider action to approve a Tree Removal Permit on property zoned Form-Based Urban Village District (FB-UV). The subject properties are located at the southwest corner of Main and Oliver Streets, being Lot 1, Block A of Wall Addition, and the northwest corner of Dennis and Oliver Streets, being Lot 6, Block A of Oliver's Addition No. 1, in the City of Rowlett, Dallas County, Texas.

# 7C. Consider action approving an Interlocal Cooperation Agreement with the City of The Colony.

Consider action to approve a change order with FCC Environmental Services, Inc. (FCC) in the amount of \$61,392.26 due to increases in commercial and residential collection fees for solid waste service (Contract 32200006, RES-069-17).

The approximately 4.34-acre site is located west of the intersection of Rowlett Road and Big A Road being Lot 7R, Block A of the Briarwood Armstrong Addition Replat, in the City of Rowlett, Dallas County, Texas.
