Consider action to approve a resolution authorizing the City Manager to execute a purchase order to CLS Equipment Co., Inc. in the amount of \$487,871.75 for the purchase of a Vac-Con Inc. combination vacuum and hydraulic jet truck to replace an aging unit that is frequently out-of-service for repairs.
