3B. Consider approval of a 30-day extension for Final Plat

Consider action to approve a 30-day extension for the review of the FBC Rowlett Addition Final Plat. The approximately 28.822-acre site is situated in the Thomas Lumley Survey, Abstract Number 789, at the northeast of the intersection Main Street and President George Bush Turnpike in the City of Rowlett, Dallas County, Texas.

3C. Consider approval of a 30-day extension for Preliminary Plat

Consider action to approve a 30-day extension for the review of the Vista North Shore Preliminary Plat. The approximately 35.314-acre site is situated in the Richard Copeland Survey, Abstract Number 229 and the Walter Caruth & Brother Survey, Abstract Number 363, and is located at the northwest corner of Castle Drive and Merritt Road, in the City of Rowlett, Dallas County, Texas.

4. INDIVIDUAL CONSIDERATION

Conduct a public hearing and make a recommendation to City Council on a request by the City of Rowlett to rezone the subject property from Planned Development to Single-Family Residential (SF-40) District and Limited Commercial (C-1). The approximately 25.426-acre property consisting of two parcels is located northwest of the intersection of Chiesa and Miller Roads in the James Hobbs Survey, Abstract No. 571, and addressed as 3399 Chiesa road and 6921 Miller Road in the City of Rowlett, Dallas County, Texas.
