- **7B.** Consider action to approve a resolution authorizing the City Manager to enter into an agreement with Hellmuth Obata Kassabaum LP (HOK) for Realize Rowlett 2020 Phase II.
- **7C.** Consider action to approve a resolution awarding Bank Depository and Merchant Card Services to American National Bank and authorize the City Manager to enter into an agreement after City Attorney approval.

- **7D.** Consider action to approve a resolution awarding the bid for the five-year lease purchase financing of one 2011 Dodge Ram Chassis with Frazer Type I Ambulance Module to Branch Banking and Trust (BB&T) Governmental Finance in the amount of one hundred forty-three thousand one hundred forty-six dollars and twenty cents (\$143,146.20) utilizing an interest rate of 1.75%.
- 7E. Consider action to approve a resolution awarding a contract to XIT Paving & Construction, Inc. for the Martin Drive Reconstruction Project from Industrial Road to SH66 (Lakeview Parkway) with a Base Bid amount of eight hundred eight thousand twenty-one dollars and thirty-nine cents (\$808,021.39), and approving a contingency amount of eighty thousand eight hundred two dollars and fourteen cents (\$80,802.14) (10%) for a total project budget of eight hundred eighty-eight thousand eight hundred twenty-three dollars and fifty-three cents (\$888,823.53) and authorizing the Mayor to execute such agreement in a form approved by the City Attorney.
- 7F. Consider a resolution determining the necessity to acquire a tract of land of approximately 0.033 acres owned by Rest Haven Funeral Home, Inc. for the public purpose of acquiring drainage easements and for construction, access, and to allow for the conveyance of drainage for the Kyle Road project; authorizing the City Manager to acquire said property; and authorizing the filing of proceedings in eminent domain to acquire the property.
- 7G. Consider a resolution determining the necessity to acquire a tract of land of approximately 0.149 acres owned by Texas Princeton Land, L.L.C. for the public purpose of acquiring drainage easements and for construction, access, and to allow for the conveyance of drainage for the Kyle Road project; authorizing the City Manager to acquire said property; and authorizing the filing of proceedings in eminent domain to acquire the property.
- **7H.** Consider a resolution authorizing the acceptance of a dedication of a water utility easement on parts of Lots 21 and Lot 22, Block F, of the Lake Valley Estates Phase II Subdivision.
- 7I. Consider approving a resolution authorizing the City Manager to execute a License Agreement with Dallas Area Rapid Transit for the construction, installation, maintenance, and operation of one 12-inch sanitary sewer line within a 20-inch steel casing pipe crossing the North East Garland Line approximately 250 feet north of Miller Road at Mile Post 744.85, in Rowlett, Dallas County, Texas.
- 7J. Consider action to authorize the final acceptance of the 2011 Contract for Concrete Repair/Maintenance of Streets and the release of retainages in the amount of one hundred sixty-two thousand four hundred ninety-nine dollars and ninety-two cents (\$162,499.92) plus accrued interest on the retainages to Tri-Con Services, Incorporated, and authorizing the Mayor to execute the necessary documents.
- 7K. Consider action to approve a resolution authorizing the first of two one-year options to extend the annual bid for concrete repair of streets and alleys to Tri-Con Services, Incorporated in the unit amounts bid and an estimated annual amount of one million three hundred thousand dollars and no cents (\$1,300,000) and authorizing the Mayor to execute the Standard Public Works Construction Contract for said service.
