- **7B.** Consider a resolution indicating concurrence with the Dallas Area Rapid Transit (DART) organization to a land swap agreement between the City of Rowlett and DART, related to the Blue Line extension of Light Rail Transit to Downtown Rowlett.
- 7C. Consider action to approve a resolution awarding a bid to Irricon Construction for drainage and sidewalk construction improvements on Chiesa Road at Pennridge Circle and at Schrade in the amount of four hundred ninety-nine thousand six hundred and thirty-six dollars (\$499,636) and authorizing the Mayor to execute the Standard Public Works Construction Contract for said services.
