- V. Staff will present a proposed rezoning request for the purpose of answering preliminary questions from the Commission prior to the formal public hearing scheduled for October 29, 2013.. The Subject Property is located at 3100 Merritt Road, further described as a 28.532 + acres portion of 31.59 + acre Tract 2 in the McKinney and WMS Abstract, Number 1015, Page 460 in the City of Rowlett, Dallas County, Texas. The applicant requests a rezoning from the existing Planned Development (ORD-052-06) Zoning District to the Urban Village Form Based Zoning District for the purposes of building a pedestrian-oriented, multi-family neighborhood to be governed by the City of Rowlett's Form Based Code.
